The City of Gulfport hereby advertises for bids for **JONES PARK IMPROVEMENTS, PHASE 2 (JONES PARK DRIVE & 20th AVENUE)** as follows:

Description of Basic Work: The Contract Work consists of the following: Road construction including earthwork, granular base, asphalt paving, erosion control, striping, signage, street lighting and other related work.

Minority and women's business enterprises are solicited to bid on this contract as prime contractors and are encouraged to make inquiries regarding potential subcontracting opportunities and equipment, material and/or supply needs.

This project is funded through the City of Gulfport's Katrina Supplemental Community Development Block Grant Program from funds provided by the Mississippi Development Authority through the U.S. Department of Housing and Urban Development, and the successful bidder must comply with all federal, state and local requirements contained in the Contract Documents.

Section 3: Section 3 of the Housing and Urban Development Act of 1968 requires the City and contractors participating in CDBG project give opportunities for job training and employment to lower income residents of the Section 3 area that is described as the City of Gulfport, Harrison County, State of Mississippi. Section 3 also requires that "to the maximum extent feasible" contracts for work in connection with Section 3 covered projects be awarded to business concerns that are located in or owned in substantial part by persons residing in the Section 3 area.

Bid Security: Each Bidder must deposit his Bid Security in the amount, form, and subject to the conditions provided in the Instructions to Bidders.

Certificate of Responsibility: Attention of all Bidders is called to the provision of Mississippi Law which requires a current Certificate of Responsibility for all contractors submitting bids for this project.

Mississippi Preference Law: Attention of all Bidders is called to the provision of Mississippi Law requiring out-of-state Bidders of Construction over \$50,000 to provide a copy of their State's Preference Law. The Mississippi law essentially limits out-of-state Bidder participation to the reverse of the Bidder's State/Local law.

Pre-Bid Conference: A Pre-Bid Conference to discuss the scope of the project and the requirements of the Bidding and Contract Documents will be held at 10:00 A.M., Local Time, on January 7, 2010 at the Handsboro Community Center, 1890 Switzer Road, Gulfport, MS.

No Bidder may withdraw his Bid within sixty (60) days after the actual date of the opening thereof.
